Co-Secretaries Report

Co-Treasurers Report

David Gelineau reported that the month's beginning balance was \$47,254.19 and after additional dues and expenses the ending balance is \$46,669.41. There were no questions or comments on the treasurer's report. A motion was made to accept the report and duly seconded. Motion passed.

CommBuys Enablement Team for Municipalities

Barbara stated that CommBuys held to regional meetings, Malboro and Holyoke, and both meeting went well.

On December 10th CommBuys is meeting with the vendor community to demonstrate how the software can help them find contracts and new opportunities for business. This training will take about 2-3 hours. Also part of the training will discuss how vendors can get on OSD contracts.

CommBuys staff is still encouraging municipalities to invite the training team to their location for more discussion and training.

Last week Mary met with the CommBuys team and called it an eye opening discussion. She said it was very simple and the team is more than willing to help with any issues.

New Business and Member's Agenda Items

There was a short discussion regarding the French River Collaborative. The FRC bid out a heating oil contract for their school and then offered this contract to other municipalities. It was a good price; however, non-profit agencies are not allowed to bid on behalf of government agencies.

Speaker Presentation

Eric Weiss and his team from MHEC gave their presentation on the history and future of the MHEC.

Eric introduced his team and talked briefly about how he came to be at the MHEC. He also assured the membership that the MHEC bids and contracts with vendors in accordance with all Massachusetts State bid laws and all municipalities and non-profits are allowed to utilize their contracts.

Eric mad a point to say that procurement is not just about spending but also about "savings". In order to emphasize the value of the job and position of procurement the profession needs to demonstrate how we "save" money and obtain value.

Eric then proceeded to speak about MHEC's critical strategic partnerships. Two of these partnerships are with the OSD and the Massachusetts Library System. A good example of why these partnerships are so valuable is the MLS. The MLS provides the content (what they need) and the MHEC provides the expertise in bidding and contracting. Together they are able to obtain good products and services at a lower cost. The partnership also saves time for both parties and lowers the purchasing risks. It also gives the MLS access to not only their vendors but, all the vendors that the MHEC utilizes.

Eric then discussed "What You Can Do" to make MHEC even stronger and more valuable to your municipality. His suggestions involved: making yourself aware of what contracts are available, utilize the contracts, keep MHEC up-to-date with your needs, and confirm your contract spend volume, and provide feedback and suggestions. In return, MHEC will provide you with a savings report; make your job easier by doing the research and bidding out the contracts.

MHEC is one of the largest purchasing consortiums in New England. They are currently expanding rapidly in Connecticut, especially in the college and university communities. The municipalities in CT are just starting to reach out to MHEC.

The current and future efforts of the MHEC will revolve around increasing membership (currently 560 members); insuring that contracts remain relevant; reach out to the membership to understand their needs and concerns; keep track of membership spend volumes; improve website and its accessibility; upgrade the bidding software; and, help and serve.

Eric and his team spent some time reviewing the types of contracts offered and the vendors on that list. A handout, "Library Quick Reference" detailing the MLS contracts was passed out. A discussion was held on how and when MHEC will be upgrading their software and improving their website. Along with this discussion the team demonstrated how to search for contracts on the website and how to access the video training material.

Lastly Eric and his team reviewed the correspondence sent via e-mail: Monthly Strategic Partnership Showcase and Ed Save and the newsletter (3 xs per year). These e-mails not only provide information on the current contracts, new vendors, changes to contracts, and savings; but, also information on members and job openings.

Lastly, Eric and his team invited everyone to MHEC's Holiday Open House on December 10th in Amherst.

Eric thanked the MAPPO members for allowing him and his team to host the meeting and present.
