LEGISLATIVE UPDATES

The Legislative Committee has been approached by the Office of the Inspector General to discuss legislation the intend to put forth. The potential bills look to contain much of the same language included in the OIG's last tranche of bills in the previous cycle that did not move forward. It includes language to close administrative loopholes, fix the much maligned "no RFPs under \$50K" issue, and grant them the authority to promulgate various rules. The Legislative Committee will be meeting with representatives from the OIG to discuss their proposed language and to weigh in on how this will impact our member communities.



30B EMERGENCY PROCUREMENT AUTHORITY ADVISORY

The Division of Local Services (DLS) recently released an alert to inform procurement officers responsible for purchasing COVID-19 related goods or services on an expedited basis that C30B allows for emergency procurement authority. ASSOCIATE MEMBER FEES

As we continue to navigate meeting remotely, we wanted to address some concerns regarding Associate Member fees. Associate members have always paid for each meeting they attend, earning CEUs for each meeting. Prior to COVID, the Associate Members' fee to attend a monthly meeting was \$25. As we moved to a remote setting, and after having several conversations with other organizations on how they were proceeding with their meetings due to COVID and the inability to meet in person, we found that other organizations were not discounting their fees. It was brought to the Executive Board and then agreed upon by the Officers that we would charge a smaller fee of \$10, since we are not taking part in lunches, in order to cover Speaker fees as well as other expenses as an Organization.

The Purchasing Agent reports to the Finance Director and oversees the town and school's procurement process, including preparing bids and requests for proposals, advertising, and reviewing and recommending contracts. They are responsible for ensuring the town is in compliance with Massachusetts General Laws. They coach department heads on smaller contracts and provide expertise on bidding, contracts and negotiations.
